A closing statement is a statement made at the end of a debate, or more often, a legal trial, delivered by a representative of each side of the case or debate. It is the last chance for both parties of said debate or trial to state their argument, and hopefully affect the verdict or outcome in their favor.

A brief summary of your argument may be useful, especially if your essay is long--more than ten pages or so. But shorter essays tend not to require a restatement of your main ideas. Avoid phrases like "in conclusion," "to conclude," "in summary," and "to sum up." These phrases can be useful--even welcome--in oral presentations.

Ending the Essay: Conclusions

A good closing argument reviews the evidence presented at trial. If you can, practice your closing with other attorneys on your team or with consultants. "It's no different than an oral argument, the preparation is the same," O'Donnell said. "Think about what you want to tell the jury.

How to conclude an essay: Restate the thesis by making the same point with other words (paraphrase). Review your supporting ideas. For that, summarize all arguments by paraphrasing how you proved the thesis.

How to Write a Strong Conclusion for Your Essay

The body of your essay should contain the meat of your argument. Go into more detail about the two sides of your topic and state the strongest points of the counter-side of your issue. After describing the "other" side, present your own viewpoint and then provide evidence to show why your position is the correct one.
