These template letters and work papers can be tailored by auditors to suit the firm and/or the engagement, as required. Note: The CaseWare SMSF Audit template also contains an Engagement letter, a Trustees Rep Letter and the Audit Report.

SMSF Audit letter and workpaper templates

Write the name of the trustee, his address, city, state, and zip code about one-quarter inch below the date. Reference the name of your trust, and your trust account number if applicable. Write a salutation followed by a colon, for example, "Dear Mr. Jones:"If you'd rather type the letter and print it out instead of writing it by hand, you can do that if you wish.

How to Write a Letter Requesting Money From a Trust ...

Typically, a separate engagement letter is not necessary for trustee services. The trust document serves as the "contract" for services. Consequently, the CPA firm's legal counsel should review the trust document to ensure that it defines the scope of the services and the responsibilities of others, including any co - trustees and beneficiaries.
