### Florida Pesticide Certification Exams

Applicators must pass a pesticide applicator exam for either Private or Commercial pesticide applicator certification depending upon the type of certification needed.Both of these exams are closed-book. Additionally, commercial applicators must register to take separate exams for certification to practice each additional Commercial pest control category.

### Pesticide Applicator Certification Exam

Practice questions for a pesticide applicator license exam include which body parts are most likely to be exposed to pesticides, how to store specific pesticides properly and the definition of biological control. Other questions include how to apply different types of pesticides and how to avoid long-term exposure.
